#### **RULES & REGULATIONS FOR ADMISSION**

- Certified photocopy of statement of Marks is required to be enclosed with the application at the time of submission.
- All reservation category candidates have to submit caste & income certificates.
- Students from other than Bangalore University have to submit migration certificate.
- Admissions are made only after Group Discussion & Personal interview with the Admission Committee.
- Candidates shall produce the Original Marks Cards, Transfer Certificates, 21 recent Passport size photographs at the time of admission.
- Students from other States should enclose copies of Migration. NRI and foreign students also have to submit Eligibility certificates.
- Payment of prescribed admission fee should be made on or before the date notified in the college, failing which the admission is forfeited.
- Amount once paid towards admission is not refundable, adjustable or transferable. Admission is provisional subject to ratification by K.S.L.U.
- A minimum attendance of 75% in each subject is compulsory. Please note that sudents who do not have adequate attendance will not be eligible to write the university examination.
- Moot Court Programme is compulsory as instructed by the K.S.L.U.
- Parents / Guardians are required to meet the Principal / Faculty members concerned to ascertain the attendance & progress of their wards atleast twice in the academic year.
- Any act of misconduct and indiscipline shall be seriously viewed for both penalty and punishment and the decision of the Principal is final in this matter.
- Participation in extra curricular activities like N.C.C., N.S.S., etc., is desirable through voluntary.
- Morning Prayer is compulsory for all students.
- Students should strictly adhere to the dress code specified by the management.
